3. All vehicles will be out of the festival area by 7:30 am and booths should be ready to operate at 8:00 am. Booths must be open until 5:00 pm and be disassembled between 5:05 pm and 6:00 pm. Those vendors assigned to the outside of Palo Pinto may not bring their vehicles in until the center section is cleared! Anyone who violates this rule will not be invited back!
